# CHESTICO PLACE DEVELOPMENT

### **1.0 INTRODUCTION AND BACKGROUND**

The Chestico Museum and Historical Society (est. 1978) is a registered not-for-profit heritage society located in Port Hood, Nova Scotia. The Chestico Museum and Historical Society has preserved, interpreted and educated the community on its local history and culture. As an active member of its community, its declared vision is to be "a beacon and cultural hub engaging our heritage and inspiring our story". However, the physical location of the museum is creating a barrier to its future growth and potential increased visitation.

## **2.0 PROJECT DESCRIPTION**

The Chestico Museum and Historical Society is exploring avenues to leverage resources (physical, social, human and financial) to partner and procure the funding to build a new multiplex that would replace the current museum which is presently located in a former schoolhouse. This new development project would house a heritage centre with a particular focus on the story of the Gaels who settled in our county as well as highlighting other aspects of local historical and cultural significance. It would accommodate the establishment of an Inverness County Archives and Genealogical Research Centre. The Chestico Museum and Historical Society has obtained a new site location for this multiplex closer to Port Hood which will increase access and raise its profile in the area. Its close proximity to the Celtic Shores Coastal Trail and other amenities will enhance recreational opportunities and increase both local and tourist visitation to central Inverness County. This project must be procured using a partnership approach to foster sustainable development. The Chestico Museum and Historical Society is requesting partnerships and collaboration from county organizations and businesses willing to envision and discuss our collective capacity to potentially build this key piece of Inverness County infrastructure. The purpose of this request for partnership is to identify and assess interested partners to carry this work forward.
